

# Food Safety Certification Training and Examination

Sponsored by Alameda County Environmental Health, 1131 Harbor Bay Pkwy, Alameda, CA 94502

California law requires that at least one person responsible for food safety at each food facility be food safety certified by passing an approved examination.

**\*\*Re-Certification is required every five years**

## Who should be certified?

The certified employees can be the owner, manager, or an employee responsible for safe food handling. The certified person is responsible by law for teaching other employees to use proper food handling techniques.

## Topics covered in the training:

The intensive 8 hour training covers these topics:

- Causes of foodborne illness and ways to prevent it
- Time and temperature controls
- Cross-contamination
- Cleaning and sanitizing
- Rodent and insect control

Participation in the training does not guarantee passing the examination. Participants are encouraged to review study materials prior to attending the class.

## The classes:

Classes begin at 8:30 AM and last eight hours. The examination will be given during the last two hours of the course. The cost is listed below. A booklet will be sent to the mailing address on the registration form.
