Rs. 1,500/- for each additional MW of capacity installed exceeding 3.000 MW and up to 97 MW and fraction if any rounded off to the next higher MW. iv. Rs. 1,50,000/- for Individuals or companies in the same group provided the installed capacity is in excess of 98 MW. However, companies having an installed capacity of 98 MW or less would be covered by the above subscription fee structure. v.
