Hey Jim,

My apologies for taking so long. We're in lay-up at present and most of my crew that was on board in Pearl are now gone. It's been crazy busy... what's new with ships.

- The guys used the EnviroKlean on the machinery space decks and said it worked well, on par with the Drew products we've been using, and to date we've not noted any difficulties processing waters (collected in our bilge system) through our OWS.
- We treated one of our bilge pockets (that our shop wash sink drains too) with the Liquid Life Forms Bacterial Digestant. As you may remember, we had an issue with a scum film on, and odor coming from this bilge pocket. I'm happy to say the film and odor, both appeared to clear up within a week of treatment with your product. Once again, no OWS problems have been noted.
- The galley crew have been using your products and their overall review has been positive. Apparently the stainless cleaner and surface disinfectant have worked very well in comparison to the products they had been using.

Thanks again for allowing us to test your products. Best wishes for success in getting your line of cleaners approved and into the supply contract chain.
